MEMBERSHIP ELIGIBILITY

Any natural, legal or a group of person(s) eligible for membership of the society may apply to be a member by completing an "application for membership" form, and may be admitted if they meet the following requirements:

- a) Is within the field of membership provided for in the bylaws.
- b) Is not less than eighteen years of age, junior actions to attach ID copies of guardian.
- c) Not carrying out money laundering.
- d) Is of good character.
- e) Has regular income from employment, business or trade.
- f) Has paid entrance fee as prescribed in the membership policy.
- g) Has understood the objectives of the Society, his obligations as a member and other membership requirements as stated in the Society By-law.

MEMBER'S RIGHTS

The following are the rights that you enjoy as a member of Nrs Sacco:

- a) Receiving, periodically and regularly, or upon request, and at least once a year, a statement of accounts containing the individualized record of his credit and debit transactions.
- b) Attending and participating in elections within the electoral zone. Each member shall have one vote irrespective of his/her total shareholding.
- c) Electing or be elected as an officer of the society, unless otherwise prohibited by any other law or those by-laws.
- d) Using the society's service according to the policies and procedures approved by the Board of Directors.
- e) Submitting projects or initiatives to the board of directors, for the improvement of the society's services.
- g) Appointing a nominee.
- h) Participate in sharing of the society's surpluses.
- i) Access all legitimate information relating to the society, including internal regulations, registers, minutes of the general meetings, supervisory committee reports, annual accounts and inventories, investigations reports, at the registered office of the society subject to the society's policies and regulations in force at the time.
- j) Voting on all matters put before the electoral zone.
- k) Enjoying all other rights as prescribed by the co-operative act and the rules.

MEMBERS' OBLIGATIONS

As a member of Nrs Sacco you are obliged to:

- a) Be faithful and honest in all their dealings with the Society.
- b) Observe the law, the rules and those by-laws whenever transacting any business with the society.
- c) Observe the code conduct and ethics of the society, and in particular desist from any corrupt practices in all dealings with the society.
- e) Protect the image of the society and avoid unnecessary publicity, incitement or careless talk that can injure the reputation of the society.
- f) Inform the Chief Executive Officer in writing of changes of my physical address and contact details whenever they occur.
- g) Pay my debt obligation to the society without fails and save regularly with the society.
- h) Seek co-operative education to improve awareness and enlightenment on co-operative matters.
- i) Attend meetings and education forums and take part in Society's decision-making.
- j) Inform non-members and encourage them to join the Society.
- k) Identify problems affecting the Society and suggest solutions.
- l) Participate in the Society's projects, both physically and financially.
- m) Make use of the services of the Society as stated in its objectives
- n) Comply with these By-laws, the Co-operative Act, the Sacco Act, Rules, Regulations and resolutions
